



OBJECTIVE

Formalize the **mandate** of an agent: its mission, its authorization scope, its limits, its level of **delegated autonomy**, its data, its supervision and its **official validation**. The mandate is the **enforceable** reference document binding the agent and those who govern it. (DDAO = Delegated Decision Agent Officer.)

SUGGESTIVE

 the agent proposes, the human decides

CO-DECISION

 human validation before execution

SUPERVISED AUTONOMOUS

 acts alone, post-hoc control

AUTONOMOUS

 acts alone, without systematic control

Carry over the agent's overall maturity (N0 → N3, ACF-05). Autonomy is set **decision by decision** (ACF-02 / ACF-03) · distinct from maturity.

✓ BEST PRACTICES

- ✓ List prohibitions as explicitly as authorizations
- ✓ Set autonomy decision by decision, not in bulk
- ✓ Review the mandate on a fixed schedule and after any incident

⚠ WATCH-OUTS

- ! A mandate without a quantified cap is not enforceable
- ! Do not conflate maturity (N0→N3) with per-decision autonomy
- ! No production deployment without the 4 signatures

What's next: this mandate frames the **agent card ACF-05**, applies the autonomy set in **ACF-02 / ACF-03**, traces decisions in the **ACF-09 registry**, can be halted via the **ACF-07 kill switch**, and is supervised with **ACF-06**.
